**NEW 2011-12 RULES & REGULATIONS**

- i) 3 man shout-out to determine winner of regular season games that end regulation time in a tie. The team that tied the game prior to the end of regulation time will shoot 1<sup>st</sup> (instead of home/away benches). If the game is tied 0-0 at the end of regulation, the referee will choose the team that shoots 1<sup>st</sup>.
- ii) Slashing above the hands will be a minor penalty. Intentionally shooting the puck at the referee will be a game misconduct. Second offense, player will be suspended for the remainder of the season.
- iii) All face-offs will occur at a dot that does not advance the location of the puck at the time of the whistle. The face-off after a penalty is called will be in the defensive zone of the team penalized.
- iv) All teams will get 1 time-out per game during the playoffs including round robin play
